## NEW ENGLAND COUNCIL WORLD'S FAIR CORPORATION

The participation of the six New England States in a single exhibition is an historic first venture for the states themselves and their exhibition is the only American regional one at the World's Fair.

The tremendous job of over-all direction of the joint venture and the management of the \$2.7 million in funds voted by the six legislatures for the project as well as the \$1 million contributed by private industry to the Exhibition has been the responsibility of the New England Council World's Fair Corporation.

The non-profit Corporation came into being when the participation of the states became a reality. Its officers and members are distinguished citizens of each of the six states who have donated generously of their time and abilities to make the New England Exhibition happen.

Contract awards to architects, builders, operators of the restaurant and the country store, other contracts for public relations and various services were made after study by special committees of the corporation whose members have literally lived with and breathed every step of the paper organization and finally the construction and staffing of the exhibition.
