Dear Commissioner Moses:

In Judge Rosenman's absence I am submitting herewith, in accordance with your memorandum of January 25th, the following report on the various exhibits and/or concessions for which we are responsible.

1. Historical Museum

As reported in a separate letter of even date herewith, Mr. Procopiu has been taken ill and authorization is requested to conclude negotiations with his associate, Mr. Louis Walter.

2. The Last Frontier

Arlington Hat Company is investigating the possibility of it becoming the sponsor of this project in conjunction with a film or amusement company or a rodeo.

3. Night Club

Mr. George Krulik is interested in operating a night club in the Lake Area featuring jazz music. Mr. Jean Buchet is interested in operating a night club in the Lake Area featuring continental entertainment.

4. Italian Restaurant

The operator of a number of Howard Johnson restaurants in mid-Manhattan is interested in operating an Italian restaurant in the Lake Area. This will create competition for this type of concession with the Milke brothers from Buffalo.

6. Jai-Alai Arena

The Florida operation involves Pari-Mutuel betting. The New York version would be operated solely for the viewing entertainment of people in the Arena. The Arena will include a restaurant, the tables of which would have a full view of the playing area. They are anxious to proceed promptly. Authorization is being requested in a separate letter.
